Election Notification for the Year – 2020

The Election Commission of the Indian Psychiatric Society invites NOMINATIONS from the ELIGIBLE LIFE FELLOWS of the Indian Psychiatric Society to the following post:

Eligibility (Please Read carefully)

- ❖ Any bonafide Life Fellow of the Society is eligible to be nominated for the election for the posts of Vice-President cum President-elect, Honorary General Secretary, Honorary Treasurer and Honorary Editor, who should be requiring additional qualifications, as given below and for the posts of Direct Council Member, if his/her nomination is proposed by a Life Fellow and seconded by another Life Fellow, provided the bonafide Life Fellow so nominated has expressed his/her consent in writing to be nominated for the said post.
- ❖ The Life Fellow nominated for the **post of Vice-President-cum-President-elect** must be a Life Fellow of the Society for at least 10 years and must have served for at least one full term of three years as a member of the Executive Council of Indian Psychiatric Society.
- ❖ The Life Fellow nominated for the **post of Honorary General Secretary, Honorary Treasurer and Honorary Editor** must be a Life Fellow of the Society for at least 5 years and must have served for at least one full term of three years as a member of the Executive Council of Indian Psychiatric Society.
- ❖ The International Life Fellows shall not be eligible to be nominated for any elected post in the Council.
- ❖ The Life Fellow, who has served on **the post of Honorary General Secretary, Honorary Treasurer, or Direct Council Member** for two terms, cannot be re-nominated again for the same post. The Life Fellow, who has served on **the post of Honorary Editor** for three terms, cannot be re-nominated again for the same post.
- ❖ **Hon. General Secretary or Hon. Treasurer or Hon. Editor** who desires to get nominated for the election of any other post of office bearer **shall be eligible only after one year from the end of his current tenure** as Hon. General Secretary or Hon. Treasurer or Hon. Editor.
- ❖ If the audited accounts of any ANCIPS or any Mid-Term CME of the Society have not been submitted to the Council within one year of the conclusion of the event; **the Chairperson, Secretary and Treasurer of the Organizing Committee** of the event will not be eligible to hold any elected post of the Society for a period of three years and if Life Fellow is already elected, he/she should be disqualified.
- ❖ The candidates must send their bio-data (not exceeding 100 words) with recent photograph along with nomination. Nominations without **self-attested bio-data, photograph and scanned photo id** (PAN Card/Voter ID/Valid Driving license/Aadhaar Card/IPS Membership Card) are liable to be rejected. Bio-data exceeding 100 words will be edited by the Election Commission.

- ❖ The Nomination Paper must contain the signatures of Life Fellows as Proposer, Seconder and Nominee. The Official Nomination Form is enclosed herewith.
- ❖ The Nomination Form must be complete & correct in all respects. Any blank or wrong entry in the form shall render the NOMINATION invalid.
- ❖ The candidate must fulfill all eligibility criteria **on/before 15th September 2019**, the last date of submission of nomination papers by email only.

The completely filled nominations in the attached format must be scanned and the documents must be sent as attachments to an email on which only the phrase 'NOMINATION' shall be mentioned in the subject area of the email. The mail must be sent at the official e-mail address of the Election Commission at ipselection2020@gmail.com


Canvassing:
